MATTER RE: PARKS SUPERINTENDENT'S REPORT
Facility/Park Report Submitted by Matt Beeman
This is a brief report regarding our main facilities and parks.

Buckland Park

Great number of participants have required a greater effort to maintain the fields.

Corbett's Glen

Committee has met: Matt Beeman, Dennis Adams (Chair), Mike Zobel, George Smith.
Issues: parking, erosion, dogs, overuse and others.

Upper Glenn parking –Temple Sinai – under consideration with Temple Board though they seem reluctant. Redevelopment in future may provide an entree to re-consideration.

Glenn Rd parking – Turn around sign in place.

Boundary tree – responsibility:
Ken Gordon considering liability issues. RG&E called re tree in lines

Brickyard Trail

Tree came down near the bridge. Being removed.

Crosswalk at Westfall: Trail connection at Buckland is first step. Part of 2018 Farm Market project.

Baseball Contract Review

Brighton Baseball has agreed that Town is to contract with concession. Brighton Baseball may hire attendants at concession stand for its events due to lack of volunteers.

Town Park

Accessibility improvements. – CDBG grant approval hoped for Fall, 2017.

Islamic Center overflow parking. It appears that Islamic Center has reached agreement with Paychex for use of their parking. Matt will monitor use of Town Park parking.

Town Hall playground

Sway Fun Glider – Delivery anticipated June 22 with Installation anticipated in Fall 2017.

Farmer's Market/Community Center –

Awaiting return of bid-ready documents from Architect. Expected to be 2018 project.

State funding request – pending. Genesee Regional Market funding issue under discussion.

4th of July – Crowd managers are not deemed necessary. Fire Marshall has suggested on line training. Matt reports that this program is clearly intended for indoor events. Matt anticipates about 12 staff to be available for event.

Town Pool: Fence and Clock (donation) are installed.

Louise would like to get new tables and more umbrellas for pool area. Priorities are being considered between building, tables and umbrellas. Louise and Jim have asked DiMarco Development for assistance.

The Bike Rodeo was on Sunday, June 11th with record participation of 92 children. A big thank you to the Brighton Police Department for putting together this great community program!

TOWN BOARD REPORT: reported by Councilmember Chris Werner –

Recreation has been working with the County Health Department to keep the pool facility in good standing. New fencing and a clock has been installed at the pool as well. Priorities are being set for possible future donations.

The Parks department has a continuing number of participants requiring a greater effort as far as maintaining the fields at Buckland. A committee has met dealing with issues of parking, erosion, dogs, overuse and other matters in the parks.

The baseball contract has been reviewed and it was agreed that Town is to contract with Concessionaire. Islamic Center has reached an agreement with Paychex for use of parking lot. The Sway Fun Glider is delivered and anticipated fall installation.

Awaiting bid for Farmer's Market/Recreation Center from Architect. Expected to be a 2018 project. State funding request is pending and Genesee Regional Market funding is under discussion.

Crowd managers are not deemed necessary for the 4th of July celebrations. A staff of 12 will be available to cover the event.

BHS art club painted the traffic boxes at Westfall/Lac de Ville and Barclay Square.

Bill has consulted with Supervisors of Hamburg and West Seneca about the Rent Source Inquiry legislation since both have similar legislation and both reported no issues. West Seneca has 147 section 8 households and Brighton has none. Landlords will be consulted and discussion regarding application to duplex homes where owner occupied.

Bri-Pen Senior Rides program through Lifespan requesting participation by recreation staff of which staff does not have capacity. Jim volunteered to attend committee meeting to show Brighton's support of the program. Jim reported the library crosswalk needed restriping and Bill will refer to Highway Dept.
