MR. LUDWIG: On the lot to the side there is a fancy conservatory and this is on the lot that is advertised as being for sale. Our Brighton Ordinance does not specify structures like this as far as demolition is concerned. It does talk about carriage houses and main structures but it does not talk about glass carriage houses like this or a tea house. The only way we can intentionally save this structure is to designate it and an opinion as to it's historic value John's firm could confirm this without a full blown survey. Mary Jo would you approach Marion Wilmont ? Of course the building it is associated with would have to qualify also.

MS. LANPHEAR: It certainly is associated with historic personages such as the Wilmonts.

MR. LUDWIG: We have designated in the past without a full survey. This can be designated by itself which would lower the cost of the survey.

MR. PAGE: Unless it has something special about it can it be designated?

MR. BOEHNER: Normally the process is we have the information and sent out a letter to meet with them and then a letter to start designation.

MR. PAGE: I don't see this as urgent as the main structure.

MR. LUDWIG: Is there something we should do about this structure?

MS. VANDERLINDE: I would hate to see us lose this structure.

MR. LUDWIG: We need a motion to ask John to ask Katie what she can do for \$999.00 on this parcel and we need to send a letter.

MR. BOEHNER: I agree with Mary Jo we would first need the information telling us why we need this designated with a full survey and I worry about spending \$999.00 and not having an answer. We need to ask and see what we can get for \$999.00 and putting 25 Stoneham Road on hold for now. I need to say something about the money. I try to hold at least \$1400.00 to the end of the year in case something critical pops up.

MR. LUDWIG: The procedure here would be for John to check with Katie to see if they can do something for \$999.00 and assuming they can do something do you want a tentative motion to proceed along those lines so we don't have to wait a month.

MR. BOEHER: Yes, so you want me to have the whole structure done not only the conservatory but the main house if it can be done below \$999.00.

MR. LUDWIG: Let's see what Mary Jo can dig up and what Katie can do for \$999.00 maybe we can do it for that. I don't know. Would someone make a motion to do that and the big thing is if John can provide something from Katie that has some teeth in it for \$999.00

MR. PAGE: So the motion would be to develop a survey on 99 Pelham Road and the adjacent parcel with the Conservatory in accordance with the Town's procurement policy that would be under \$999.00 and if not we will have to go plan B whatever that will be. .


