1. Approval of Minutes – Receive and file minutes of the March 20, 2018 meeting.
2. Declare Equipment as Surplus for Auction (Police Dept) – Request from Chief Henderson for Town Board action to declare one 2015 Ford Explorer as surplus and to authorize it to be disposed of at the May 12<sup>th</sup>, 2018 Municipal auction. (see memo from M. Henderson).
3. CSX Railroad Grant (DISCUSSION ITEM ONLY) – Discussion about the potential of a CSX Enforcement grant in regard to property in and around CSX railroad areas (discussion lead by D. Catholdi).
4. Bid Award for Blossom Road Sanitary Sewer Improvements (Public Works) – Request from Mike Guyon for Town Board action to award the contract to Villager Construction, Inc. in the amount not to exceed \$395,945 (includes bid amount of \$359,950 plus 10% contingency \$35,995). Also, the project amount exceeds the original bond total project amount of \$350,000 and the bond resolution will need to be amended to reflect the total project cost of \$439,545 (bond amount of \$350,000 will not change) and will utilize the additional cost of \$89,545 from assigned fund balance (see memo from M. Guyon).
5. Bid Award for Green Infrastructure Maintenance (Public Works) – Request from Mike Guyon for Town Board action to award the contract to Plant Concepts, Inc. in the amount of \$16,188. Funds are available in A.DPW.8510 4.11 (see memo from M. Guyon).
6. Contract Extension with Price increase for Spin Rite (Public Works) – Request from Mike Guyon for the Town Board to authorize the first of four contract extensions with Spin Rite, Inc. for sidewalk repair services. Only one item in the contract is being increased resulting in an overall contract increase of 2.7%. Funds are available in the Sidewalk District and the Townwide Sidewalk accounts (see letter from M. Guyon).
7. Discuss scheduling a meeting time for the 2017 Annual Financial Statement review – April 17<sup>th</sup> tentatively at 3:30 pm. (about 1 ½ hours for audit review).

Dear Councilperson DiPonzio and Committee Members:

The bids for the above referenced project were publicly advertised and publicly opened, all as required by law. Bids were received and opened on March 22, 2018 at 10:00 AM. A copy of the bid advertisement is attached for your reference.

Three utility contractors and three bid distribution firms obtained bidding documents, however, only one contractor, Villager Construction Inc., submitted a bid proposal. The total base bid amount is \$359,950.00. It is customary to request that the Town Board authorize the supervisor to approve a construction allowance of 10% to accommodate potential change orders. The total base bid plus a 10% allowance increases the total construction cost to \$395,945.00.

The project design consultant, Lu Engineers, reviewed the bids for completeness and accuracy and provided a recommendation letter indicating that the bid submitted by Villager Construction, Inc. is competitive and there was no evidence of an unbalanced bid. Additionally, the letter recommended that Villager Construction Inc. be awarded the Blossom Road Sanitary Sewer Improvement project base bid. A copy of this letter is attached for your reference.

The Town of Brighton issued a bond resolution in the amount of \$350,000 to fund the project. The total cost of the project including the 10% construction allowance is \$436,645 as shown in table 1. The total project cost exceeds the bond amount by \$89,545.00. The New World finance system suggests that the unassigned 2018 Consolidated Sanitary Sewer District Unreserved Fund Balance is \$480,316.43. We suggest that the unreserved fund balance be considered to fund the project overage of \$89,545.00.

It is our understanding an amendment to the new bond resolution will need to be adopted by the Town Board to satisfy the NYS Local Finance Law requirements.

I am requesting that FASC recommend that the Town Board award the bid to construct the Blossom Road Sanitary Sewer Improvements to the low, responsible and responsive bidder, Villager Construction, Inc. for a bid cost not to exceed \$359,950.00. I further recommend that the Supervisor be authorized to execute any necessary change orders that do not collectively exceed ten percent of the awarded contract price.

Additionally, we are suggesting that the 2018 Consolidated Sanitary Sewer District Unreserved Fund Balance provide additional funding for the project. Therefore, I am requesting that a total of, \$89,545.00, be appropriated into account H.Sewer.Blosm from the Consolidated Sewer District Unreserved Fund Balance.

Finally, we are requesting that the Finance Committee be authorized to make the necessary budget modifications.

As always, thank you for your consideration. I will be in attendance at your regularly scheduled March 20, 2018 meeting in the event that you have any questions regarding this matter.

The work consists principally of installing four (4) new doghouse manholes on existing 18" diameter sanitary sewer mains, a plug valve and 67 +/- feet of new 16" and 18" PVC sanitary sewer, abandonment of existing manholes and sewer lines, wastewater by-pass pumping and traffic control all within the pavement limits of the New York State Route 286A (Blossom Road). Work is to be conducted on a night-time schedule between the hours of 7:00 p.m. to 6:00 a.m.

The foregoing is a general outline of work only and shall not be construed as a complete description of the work to be performed under this contract. Plans and Specifications are available for inspection at the above location or you can download them from the Town's website ([www.townofbrighton.org](http://www.townofbrighton.org)) under the Town Departments - Public Works - Current Bid Offerings.

The Engineer will conduct a Prebid meeting on March 08, 2018 at 00 AM, local time at the Town of Brighton Town Hall.

Bids must be made in writing on the forms furnished and shall be accompanied by a bid guarantee for an amount not less than five percent (5%) of the amount bid in accordance with the INSTRUCTION TO BIDDERS.

The Town of Brighton is exempt under New York State Tax law and therefore, no sales tax on the cost of materials incorporated in the project shall be included in the bid.

All prices bid shall be good for a period of sixty (60) days after opening.

The Town of Brighton reserves the right to consider bids for sixty (60) days after their receipt before awarding any contract. The Town of Brighton further reserves the right to reject any and all bids, and to accept any Proposal or individual item or items, which it may deem to be the most favorable to its best interests.

A noncollusive bidding certificate shall be included with each bid.

The attention of the Bidder is called to the requirements as to the conditions of employment and the minimum wage rates to be paid under the contract.

One (1) bid package was received. The apparent low bidder at the bid opening was Villager Construction, Inc. Attached is a copy of the Bid Tabulation with unit prices from each of the Contractors that submitted bids.

We have conducted an analysis of the bids received for the referenced project which was advertised for competitive bidding on February 21, 2018. Bids were publicly opened and read aloud at 10:00 a.m., local time, on March 22, 2018 at the Brighton Town Hall, 2300 Elmwood Avenue, Rochester, NY 14618. In our review of the bids, we checked the mathematics and found no discrepancies.

The total base bid amount is \$359,950.00.

We have reviewed the design of the project and we are not aware of any design changes that could be made to the project to reduce the construction cost and still be able to accomplish the goals of the project to replace the aging sanitary sewers and provide improved sewage flows.

A review of the items in Villager Construction's bid did not reveal any evidence of unbalanced bidding.

In our opinion, the analysis indicates that the bid is competitive and that the apparent low bidder (Villager Construction, Inc.) has yielded the lowest cost.

The Bid Document of the apparent low bidder was reviewed and the bidder was found to have signed and submitted the following documents, as required:

- Certification of Bidder Responsibility
- Non-Collusive Bidding Certificate
- Equal Employment Opportunity, EEO, Certification Forms
- Corporate Resolution
- Certificate of Compliance

- Site Investigation Certificate
- Bid Security Form
- Bid Bond from International Fidelity Insurance Co.

Villager Construction, Inc. is not listed on the General Services Administration's list of Debarred, Suspended or Voluntarily Excluded Firms or the Department of Labor's list of debarred firms. A check with the NYS Department of State indicates that Villager Construction, Inc. has the proper authority to conduct business in New York State. Villager Construction, Inc. has no violations listed with the Office of Safety and Health Administration over the past (5) five years.

We recommend that **Villager Construction, Inc.** be awarded the base bid of the project in the **amount of \$359,950.00 provided that the Town of Brighton has sufficient funding for the project.**

**RESOLUTION OF THE TOWN BOARD OF THE TOWN OF BRIGHTON, MONROE COUNTY, NEW YORK (THE "TOWN") PURSUANT TO SECTION 202-b OF THE TOWN LAW DETERMINING THAT IT IS IN THE PUBLIC INTEREST TO UNDERTAKE CERTAIN IMPROVEMENTS ON BEHALF OF THE TOWN OF BRIGHTON CONSOLIDATED SEWER DISTRICT**

WHEREAS, the Town Board of the Town of Brighton, Monroe County, New York (the "Town") is considering whether to authorize certain improvements on behalf of the Town of Brighton Consolidated Sewer District (the "District") consisting of the rehabilitation of the existing Blossom Road sanitary collection system consisting of the installation of one eight-foot diameter dog-house and four five-foot diameter dog-house manholes over the existing 18-inch sanitary sewer, the installation of approximately 47 linear feet of 18-inch sanitary sewers and approximately 20 linear feet of 16-inch sanitary sewers to connect the manholes, and the installation of a new plug valve, including site-work improvements and all ancillary and related work required in connection therewith (collectively, the "Project"); and

✧ WHEREAS, the Town's engineers have estimated that the maximum cost of the Project is \$350,000; and

WHEREAS, by resolution adopted on July 12, 2017, at a regular meeting of the Town Board held on such date, the Town Board directed that a public hearing be held on whether it would be in the public interest to undertake the Project and to authorize the Project, and to hear all persons interested in the subject thereof concerning the same on August 9, 2017 at 7:00 p.m. at the Town Hall, 2300 Elmwood Avenue, Rochester, New York 14618; and

WHEREAS, notice of said public hearing certified by the Town Clerk was duly published and posted as required by law, to wit: a duly certified copy thereof was published in the *Brighton-Pittsford Post*, the official newspaper of the Town, on July 20, 2017 and a copy of such notice was posted on July 13, 2017 on the signboard maintained by the Town Clerk, and on the Town's website, pursuant to Town Law Section 30(6); and

WHEREAS, said public hearing was duly held at the time and place set forth in said notice, at which all persons desiring to be heard were duly heard.

NOW THEREFORE, THE TOWN BOARD OF THE TOWN OF BRIGHTON, MONROE COUNTY, NEW YORK HEREBY RESOLVES, AS FOLLOWS:

SECTION 1. Upon the advice of the Town's engineer and attorney, the Town Board hereby determines, pursuant to the State Environmental Quality Review Act and the regulations of the Department of Environmental Conservation promulgated thereunder (6 NYCRR Part 617.5) (collectively, "SEQRA"), that the Project constitutes a "Type II" action within the meaning of SEQRA and therefore no further action need be taken by the Town Board under SEQRA in connection with the Project or as a pre-condition to the adoption of this resolution.

SECTION 2. Based upon the evidence given at the aforesaid public hearing, it is hereby found and determined that it is in the public interest to undertake the Project as hereinabove described at the maximum cost of \$350,000. The Project is hereby approved.

SECTION 3. The Town Clerk is hereby authorized and directed to cause a certified copy of this resolution to be duly recorded in the office of the County Clerk of Monroe County, New York within ten (10) days after the adoption hereof, in accordance with Section 195 of the Town Law.

SECTION 4. This resolution shall take effect immediately.

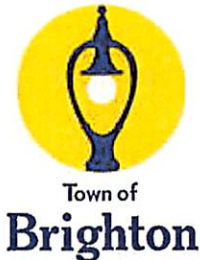

Dear Councilperson DiPonzio and Committee Members:

The bids for the above referenced project were publicly advertised and publicly opened, all as required by law. Bids were received and opened on March 15, 2018 at 4:00 PM.

Five landscaping contractors and five bid distribution firms obtained bidding documents, however, only one contractor, Plant Concepts, Inc., submitted a bid proposal. The bid requested itemized prices for each green infrastructure practice along the length of the Monroe Avenue GIGP project. The green infrastructure practices include; wetland area, bioretention areas, rain gardens, porous asphalt pavement and porous concrete sidewalk. This bid structure enables the Town to select the bid items that are essential to the maintenance of the green infrastructure and control the total cost of the maintenance contract. The bid also included an item to water the green infrastructure on an as necessary basis as determined by the Town of Brighton. A copy of the itemized bid tab showing the selected maintenance practices is attached for your reference. The total cost excluding the cost of watering to complete the selected bid items is \$16,188.00.

Account A.DPW.8510 4.11 includes \$20,000.00 for the Monroe Avenue Streetscape Maintenance. I am requesting that FASC recommend that the Town Board award the bid to provide maintenance services for the green infrastructure along Monroe Avenue to the low, responsible and responsive bidder, Plant Concepts, Inc. for a bid cost not to exceed \$20,000.00. An award of \$20,000.00 will leave \$3,812.00 in account A.DPW.8510 4.11 which could be utilized to fund approximately 5 watering trips or additional maintenance along Monroe Avenue.

Re: 2018 Sidewalk Repair Contract Extension

Dear Councilperson DiPonzio and Committee Members:

At their 2017 meeting the Town of Brighton authorized the Supervisor to execute a contract with Spin Rite Inc., to provide services associated with the 2017 Brighton Consolidated Sidewalk District and Townwide Sidewalk Repair programs. The executed agreement included an option to renew the contract for up to four additional twelve month periods at the sole discretion of the Town of Brighton. The renewal allowed for pricing adjustments if agreeable by the Town of Brighton.

Per the agreement Spin Rite Inc. is requesting to adjust the price of the Concrete Sidewalk Rubble payment item from \$0.08 to \$0.30 per square foot. The remaining payment items will be unchanged. A comparison of the 2017 Sidewalk Repair Contract Extension indicates that this adjustment would have resulted in a 2.7% increase in the 2017 contract amount and Spin Rite would have remained as the low bidder. We find the requested price adjustment acceptable and request that FASC recommend that the Town Board approve the extension of the contract based upon the prices submitted from Spin Rite Inc.

Funds are available from the 2018 Budget in the Sidewalk District account (SK.SWLKD.5411.265) of \$168,000 and in the Townwide Sidewalk account (A/DPW.5410.449) of \$16,610 for a grand total of \$184,610.
