**CONTINUING BUSINESS**

**Park Issues: Matt Beeman**

- Outdoor season winding down
- Numerous large projects have been completed
- Trail border installation at Corbett's Glen is underway. Completion expected next week.
- New park signs have continually been removed/stolen by park goers
- A trail camera or two will be installed to help discourage, identify any vandals in the park

**Recreation Programs: Rebecca Cotter**

- Finalizing preparations for Fall Halloween Events
- Working on Winter/Spring programming
- Large push to find new and different instructors and program areas
- Will be re-energizing the Winter/Spring Brochure with new programs, format and hopefully increased engagement

**Winter Farm Market Update**

- Currently out for bid
- Bid opening early November
- 2 additional \$500,000 grants received by Joe Morelle and Joe Robach

**Inclusion, Diversity and Equity Advisory Committee Update**

- Work continues on the RFP for the Consultant

- The budget has a line item of \$25,000 for consultant fees

### **Community Choice Aggregation Law Update**

- Hope is to get 4 jurisdictions together to go out for RFQ to provide service
- Provision included in MOU to allow a municipality to remove themselves from the collective at anytime
- RFQ/MOU is currently being developed
- Discussion surrounding proposed language, the process and cost savings

### **Beautification Committee Update**

- There were over 30 applicants
- 13 candidates are being invited to interview
- Interviews will be conducted in October

### **Route 96 (East Avenue) Lane Reconfiguration Update**

- Road patching work continues
- Traffic has been concerning, particularly for Allens Creek School as the project moves further down East Avenue
- Actual Road construction phase won't begin until the end of May 2019

### **Brighton Safe Streets for All Update**

- Community Group met on October 2<sup>nd</sup> to set goals
- Group met with Pace Car organizer to brainstorm ideas on how to move forward
- Working to design a Brighton Logo
- Town Leaders meeting with community groups and schools to continue conversations about safe streets and safe driving in Brighton
- Discussion on school speed limit signs being posted and crosswalk painting

## **NEW BUSINESS**

### **Police Accountability (Walkill Law)**

- Public Hearing scheduled for November 14 Town Board Meeting

### **Semi-Annual Electronics Recycling and Document Shredding Event Debrief**

- Excess of 250 cars
- Attendance was lighter than previous events
- Larger use of shredding portion, not taking televisions or monitors likely contribute to the smaller numbers
- 8 pallets of electronics collected, estimated over 10,000 pounds of shredding
