### Town Council

- Reconnect Rochester Complete Streets Makeover contest entry update: the intersection of Monroe Ave. at Torrington and Brooklawn has advanced to the pool of top 11 entries. Final selection to be made late this week. Should the intersection be a finalist (runner up or winner), it will receive an engineering and design makeover to improve safety and sense of place.

Commissioner Guyon asked to have a Town Board public hearing set to address several streets in the area to be lowered and posted for a to 25 mph speed limit.

**NEW BUSINESS:**

**RE MATTER:** Brighton Fire District Citizen Committee Update – Corrado

Executive Director Ted Aroesty addressed the committee and briefed them as to the 13-member Citizen Committee makeup and scope towards the future operations at the Clover Street firehouse (aka Station 3).

Director Aroesty further reviewed the several staff and volunteer alternatives with understanding other committee meetings are scheduled to be held.

Supervisor Moehle urged that the public needs to be able to review and understand these alternatives before a final decision is made on future staffing or operations.

Several guest/committee members added to the discussion about the complex nature of the information and needed for clarity about the recent increase of staffing in other stations and role of future operation at Clover Street (Station 3) towards timely responses and coverage of emergency responses.

Brighton Fire District emphasised its commitment that it made at the December public meeting that there would be another public meeting to discuss the recommendations of the committee prior to taking any actions
