RE MATTER:

RE MATTER: Traffic safety on Forest Hill Road – Corrado

Jennifer Bateman and Susan Wasco addressed the committee about several concerns related to traffic safety. Brighton Police shared some traffic data collected (speed / volume) and discussion about posted signage both school zone and speed limit. Continued discussion about measures that can be taken by the residents to create a sidewalk district. Chief Henderson will provide enforcement as staff allows. (Communications from concerned neighbors were submitted for the record and are attached to these minutes.)

RE MATTER: Enforcement of park rules at Corbett's Glen – Werner

Dennis Adams, chair of the Conservation Board and Chair of the Friends of Corbett's Glen addressed the committee. Discussion about parking and use of the park with respect to current and future erosions. Commissioner Guyon and Chief Henderson to review parking signage to ensure signage matches the recent Town of Brighton Ordinances. Continued discussion about barrier and use of natural materials to maintain a barrier to prohibit entry to the water in prohibited areas. Animal Control to monitor the park for compliance with the leash law and police patrol and enforcement to continue as staffing allows.

RE MATTER: Enforcement of the waterfowl ordinance – Werner

Discussion about newly adopted waterfowl ordinance and animal control to be lead agency on enforcement. Chief Henderson will talk to resident and advise this ordinance is now enforceable. Will be monitoring for future enforcement action, if necessary.
