PLANNING BOARD REPORT

HEARING DATE: July 21, 2021

APPLICATION NO: 6P-2-21

APPLICATION SUMMARY: Application of Westfall Medical Realty, LLC, owner, for Demolition Review and Approval and Preliminary / Final Site Plan Approval to raze a 6,015 sf medical building and reuse the existing foundation to construct a new 6,425 +/- sf medical building on property located at 2233 South Clinton Avenue.

COMMENTS:

- The subject property is presently zoned BE-1 Office
- Calculation for gross footage/acre is 5,113 sf/acre.
- The proposed project meets all the parking and area requirements of the Town Code.
- Westfall Park Medical is located at the southwest corner of Westfall Road and South Clinton Avenue.
- The site contains five medical office buildings and one utility building. Existing building 1, which is approximately 6,015 sf and located in the northeast corner of the property, is proposed for partial demolition. The building's roof and first floor are proposed for removal.
- The Historic Preservation Commission at its June 24 meeting reviewed the demolition application and has determined that the building is not a candidate for designation by the Historic Preservation Commission as a landmark.
- The foundation and utility connections would remain in place. A new 6,425 SF building is proposed using the existing foundation and two minor infill areas along the south side of the building. The infill areas will accommodate a new entry vestibule and additional office space.
- The new building will be sprinklered.
- The site and landscaping surrounding the existing building will be protected during construction. Any damage to the landscaping, diseased, or dead vegetation will be replaced in kind at the completion of the new building.
- The architectural design and building materials of the proposed buildings have been reviewed and approved by the Town of Brighton Architectural Review Board.

TOWN ENGINEER: See memo from Town Engineer, Evert Garcia, dated July 20, 2021.

QUESTIONS:

- Why are you demolishing the building?
- Have the architectural design and building materials of the proposed building been reviewed and approved by the Town of Brighton Architectural Review Board?
- Has a pre-demolition asbestos survey shall been prepared for the project? Will the project comply with the requirements of NYSDOL Code Rule 56 regarding asbestos control?
- What type of provisions are you providing for trash? Are the existing dumpsters enclosed?
- Are you proposing any modifications to the landscape plan that address safety, security, and legal compliance?
- Will there be any new exterior lighting proposed as part of this project?
- Will all new roof leaders tie back in to the existing storm sewer system?
- Do you propose to install a fire sprinkler system?
- Will a generator be provided?
- Where will the HVAC units be located?

SEQRA:

If the Planning Board finds that the proposed action will not have a significant impact on the environment. I would suggest that the Planning Board adopts the negative declaration prepared by Town Staff.

DEMOLITION:

If the Board entertains demolition approval, I would suggest including, among any others suggested by the Board, the following findings:

1. The existing building, if currently designated as a landmark, has received required approvals from the Historic Preservation Commission, and if not currently designated, has been found by the Commission not to be a candidate for designation by the Historic Preservation Commission as a landmark.
2. The Architectural Review Board and Conservation Board have reviewed the project per the requirements of this article and their determinations and recommendations have been

considered.

3. The project is consistent with the Brighton Comprehensive Plan
4. The project meets all Town zoning requirements.
5. The Brighton Department of Public Works has approved the proposed grading plan for the project.
6. The project complies with the requirements of the Town's regulations regarding trees.
7. A restoration/landscaping plan has been conditionally approved by the Planning Board.
8. The project will comply with the requirements of NYSDOL Code Rule 56 regarding asbestos control and Chapter 91 of the Code of the Town of Brighton, Lead-Based Paint Removal. In addition to any other requirements of Code Rule 56, the project will comply with Section 56-3.4(a)(2) regarding on-site maintenance of a project record, Section 56-3.6(a) regarding 10 Day Notice requirements for residential and business occupants, the licensing requirements of Section 56-3, and the asbestos survey and removal requirements of Section 56-5.
9. The project will not, under the circumstances of the particular case, be detrimental to the health, safety or general welfare of persons residing or working in the neighborhood and will not be detrimental to the public welfare or injurious to property or improvements in the neighborhood.
10. The project does not have a significant negative impact on affordable housing within the Town.

APPLICATION:

If the Board entertains tabling the application, I would suggest including, among others suggested by the Board, the following items be addressed:

1. An Operational Permit shall be obtained from the Town of Brighton Fire Marshal (Chris Roth, 585-784-5220).
2. The entire building shall comply with the most current Building & Fire Codes of New York State.
3. Prior to issuance of any building permits, all plans for utility and storm water control systems must be reviewed and have been given approval by appropriate authorities. Prior to any occupancy, work proposed on the approved plans shall have been completed to a degree satisfactory to the appropriate authorities.
4. Meet all requirements of the Town of Brighton's Department of Public Works.
5. All Town codes shall be met that relate directly or indirectly to the applicant's request.

6. The project and its construction entrance shall meet the New York State Standards and Specifications for Erosion and Sediment Control.
7. The contractor shall designate a member of his or her firm to be responsible to monitor erosion control, erosion control structures, tree protection and preservation throughout construction.
8. All trees to be saved shall be protected with orange construction fencing placed at the drip line or a distance greater than the drip line. Trees shall be pruned, watered, and fertilized prior to, during and after construction. Materials and equipment storage shall not be allowed in fenced areas.
9. Maintenance of landscape plantings shall be guaranteed for three (3) years.
10. Any contractor or individual involved in the planting, maintenance or removal of trees shall comply with the requirements of the town's Excavation and Clearing (Chapter 66), Trees (Chapter 175) and other pertinent regulations and shall be registered and shall carry insurance as required by Chapter 175 of the Comprehensive Development Regulations.
11. The existing dumpsters shall be enclosed with building materials that are compatible with the existing building and located in the rear yard. The enclosure shall equal the height of the dumpster.
12. The parking lot shall be striped as per the requirements of the Brighton Comprehensive Development Regulations.
13. All outstanding Site Plan comments and concerns of the Town Engineer and Fire Marshal shall be addressed.
14. All outstanding Site Plan comments and concerns of the Town Engineer regarding soil erosion, storm water control, water system and sanitary sewer design shall be addressed prior to final approval.
15. All County Development Review Comments shall be addressed prior to final approval.
16. All other reviewing agencies must issue their approval prior to the Department of Public Works issuing its final approval.
17. The project will comply with the requirements of NYSDOL Code Rule 56 regarding asbestos control and Chapter 91 of the Code of the Town of Brighton, Lead-Based Paint Removal. In addition to any other requirements of Code Rule 56, the applicant shall verify that the project will comply with Section 56-3.4(a)(2) regarding on-site maintenance of a project record, and Section 56-3.6(a) regarding 10 Day Notice requirements for residential and business occupants. The property owner shall ensure that the licensing requirements of Section 56-3 and asbestos survey and removal requirements of Section 56-5 are met.

18. Prior to the issuance of a demolition permit or building permit, asbestos shall be removed according to NYS and the Town of Brighton requirements and verification shall be submitted from a qualified company that asbestos has been removed.
19. The proposed building shall be sprinklered in accordance with Town requirements.
20. Erosion control measures shall be in place prior to site disturbance.
21. The applicant shall review the site plan, elevations, and floor plans to ensure that the areas and dimensions provided on those plans agree with one another. Elevation drawings showing the height of the structure in relationship to proposed grade as shown on the approved site plan shall be submitted. Any changes to plans shall be reviewed by the Building and Planning Department and may require Planning Board approval.
22. All comments and concerns of the Town Engineer as contained in the attached memo dated July 20, 2021 from Evert Garcia, Town Engineer, to Ramsey Boehner, shall be addressed.
23. A letter or memo in response to all Planning Board and Town Engineer comments and conditions shall be submitted.
24. Hydraulic calculations demonstrating that the proposed water distribution network has sufficient pressure and flow to accommodate the demands associated with this project must be provided prior to the issuance of a building permit for the project.
25. A sanitary sewer permit must be obtained from the Town of Brighton sewer department before construction and/or demolition can begin. The sanitary sewer must be plugged prior to the start of construction.
26. A letter of credit shall be provided to cover certain aspects of the project, including, but not limited to: demolition, restoration, and sediment and erosion control. The letter of credit should be submitted to the Town for review and approval. An original Letter of Credit must be received by the Town prior to the start of construction.
27. A sprinkler permit must be obtained from the Town's Fire Marshal.
28. As agreed to by the applicant, the plans shall be modified to address safety, security, and legal compliance. The revised plan shall be submitted to the Executive Secretary for review and approval.

This notice is issued pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law.

The Brighton Planning Board, as lead agency, has determined that the proposed action described below will not have a significant effect on the environment and a Draft Environmental Impact Statement will not be prepared.

Conditioned Negative Declaration: No

Description of Action: Demolition Review and Approval and Preliminary / Final Site Plan Approval to raze a 6,015 sf medical building and reuse the existing foundation to construct a new 6,425 +/- sf medical building.

Location: 2233 South Clinton Avenue.

Reasons Supporting This Determination:

Based on information submitted to the lead agency and after considering the action contemplated and reviewing the Environmental Assessment Form prepared by the applicant, the Criteria for determining significance in the SEQR regulations and other supplemental information, documentation, testimony and correspondence, the Town Planning Board finds that the proposed action will not have a significant impact on the environment based on the following findings:

1. Air, Water, Waste, Erosion, Drainage, and Site Disturbance.

The Project will not create any significant adverse impact in the existing air quality or water quality, nor in solid waste production, nor potential for erosion, nor promote flooding or drainage problems. The Project can be sufficiently served by existing utility infrastructure, including water and sanitary sewer facilities. The storm water drainage system will be designed and will be constructed in accordance with all applicable Town requirements. Soil erosion control measures will be implemented during and after construction based upon a detailed grading and erosion control plan.

2. Noise, Visual, and Neighborhood Character.

The Project will not impact the neighborhood character of the surrounding area nor will it create any adverse noise or visual impacts. The Project will be visible from the Westfall Rd. and S Clinton Ave and neighboring properties. The appearance of the property will remain largely unchanged. Minimal site improvements will be made to the property. No trees will be removed in the front yards. The large front yard park-like setting will be maintained with the existing trees and lawn thereby further minimizing any potential noise, visual or community character impacts.

The nature of the improvements to be made as part of this Project and the intensity of the proposed uses are consistent with the existing uses within the surrounding neighborhood (i.e., professional and medical office uses).

3. Agriculture, Archeology, Historic, Natural, or Cultural Resources.

The Project will not adversely impact agricultural, archeological, historical, natural, or cultural resources. The NYS Cultural Resource Information System (CRIS) indicates that the project area is located near archaeologically sensitive areas. Minimal site improvements disturbance will be made to the property. The Project area has also been previously disturbed during the construction of the existing office buildings and parking areas. There are no known archaeological resources within project site.

4. Vegetation, Fish, Wildlife, Significant, Habitats, Threatened or Endangered Species, Wetlands, Flood Plains.

The Project will not have a significant adverse impact on plant or animal life. The property does not host any threatened or endangered species, and therefore the Project will have no impact on any threatened or endangered species. There are no State or Federal wetlands on the property, and the property is not within any designated floodway or floodplain. Therefore, the Project will have no significant adverse impact on any wetlands or floodplains.

5. Community Plans, Use of Land, and Natural Resources.

The project is located in a BE-1 Office and Office Park and will need Site Plan and Demolition approval from the Planning Board. The Town's Comprehensive Plan does not specifically address the property. The Project is consistent with a number of the Plans recommendations. The project will continue to preserve trees in reasonable health and condition. The trees located in front yards will not be removed. Minimal site improvements will be made to the property and the large front yard park-like setting will be maintained with the existing mature trees and lawn. The project will minimize any adverse effect on the health and longevity of trees through appropriate design measures and construction practices. The Project will have no adverse impacts on the natural resources found on the site.

6. Critical Environmental Area.

The Project will not have an impact on any designated Critical Environmental Area as set forth in 6 N.Y.C.R.R. Section 617.14(g).

7. Traffic.

The existing office complex contains five medical office buildings and one utility building. The subject building, which is approximately 6,015 sf and located in the northeast corner of the property, is proposed for partial demolition. The building's roof and first floor are proposed for removal. The foundation and utility connections would remain in place. A new 6,425 SF building is proposed using the existing foundation and two minor infill areas along the south side of the building. The infill areas will accommodate a new entry vestibule and a small amount additional office space. The proposed additional 410 SF in density will not have a significant adverse impact on traffic. The existing transportation network can adequately accommodate the existing office complex traffic and the proposed additional 410 SF.

8. Public Health and Safety.

The project will comply with the requirements of NYSDOL Code Rule 56 regarding asbestos control and Chapter 91 of the Code of the Town of Brighton, Lead-Based Paint Removal. In addition to any other requirements of Code Rule 56, the applicant will verify that the project will comply with Section 56-3.4(a)(2) regarding on-site maintenance of a project record, and Section 56-3.6(a) regarding 10 Day Notice requirements for residential and business occupants. The property owner shall ensure that the licensing requirements of Section 56-3 and asbestos survey and removal requirements of Section 56-5 are met. The Project will not have a significant adverse impact on public health or safety. The Project is subject to all applicable Federal, State, and Local laws, regulations, and code requirements including all requirements of the Town of Brighton, Monroe County Department of Transportation, Monroe County Water Authority, Monroe County Department of Health, and New York State Department of Environmental Conservation.

Pursuant to SEQRA, based on the abovementioned information, documentation, testimony, correspondence, and findings, and after examining the relevant issues, including all relevant issues raised and recommendations offered by involved and interested agencies and Town Staff, the Lead Agency determines that the Project will not have a significant adverse impact on the environment, which constitutes a negative declaration, and, therefore, SEQRA does not require further action relative to the Project.

The Lead Agency has made the following additional determinations:

- A. The Lead Agency has met the procedural and substantive requirements of SEQRA.
- B. The Lead Agency has carefully considered each and every criterion for determining the potential significance of the Project upon the environment as set forth in SEQRA, and the Lead Agency finds that none of the criteria for determining significance set forth in SEQRA would be implicated as a result of the Project.
- C. The Lead Agency has carefully considered (that is, has taken the required "hard look" at) the Project and the relevant environmental impacts, facts, and conclusions in connection with same.

D. The Lead Agency has made a reasoned elaboration of the rationale for arriving at its determination of environmental non-significance, and the Lead Agency's determination is supported by substantial evidence, as set forth herein

E. To the maximum extent practicable, potential adverse environmental impacts will be largely avoided or minimized by the Applicant's careful incorporation in its application materials of measures designed to avoid such impacts that were identified as practicable.

We have completed our review of the above referenced project and offer the following comments for the Planning Boards consideration

General:

1. The letter of credit should be revised as follows:
 - a. Costs associated with demolition of the existing facility should be included in the engineer's estimate to establish the value of the letter of credit.
 - b. There appears to be computational errors included in the summation of the sub-totals in the engineer's estimate provided. Please review and revise.
2. The proposed building and site plan must comply with the New York State Fire Code. The Town of Brighton Fire Marshal must review the fire apparatus access and fire hydrant locations. The Fire Apparatus Access and Fire Hydrant Worksheet must be completed and submitted to the Town of Brighton for review. The worksheet can be found at: <http://www.townofbrighton.org/DocumentCenter/View/4557>

Engineer's Report:

1. Hydraulic calculations demonstrating that the proposed water distribution network has sufficient pressure and flow to accommodate the demands associated with this project must also be provided.

Plans

1. *Existing Site and Demolition Plan, Sheet 2 of 5*
 - a. The plans suggest that additional foundation plantings will have to be removed in order to accommodate the installation of the new fire service. Please review and revise the plans accordingly.

2. *Proposed Site and Utility Plan, Sheet 3 of 5*

- a. The design engineer has indicated that all roof leaders for the new building will connect to the existing storm sewer system. The location of the existing storm sewer and proposed conductors should be depicted on the plans.
- b. The material type for the new 4" fire service should be called out on the utility plan.

We have completed our review of the above referenced project and offer the following comments for the Planning Board's consideration:

General:

1. A note must be added to the plans indicating that any contractor or individual involved in the planting, maintenance or removal of trees shall comply with the requirements of the Town's Comprehensive Development Regulations for Excavation and Clearing (Chapter 66), Trees (Chapter 175) and other pertinent regulations. The Contractor shall be a registered tree-service provider with the Town, and shall carry insurance as required by Chapter 175 of the Town's Comprehensive Development Regulations.
2. The proposed seed mixture for areas that are to receive hydroseeding should be included on the plans. The seed mixture shall be a permanent pasture mix or other fast-growing surface vegetation to create growth within 30 days of the original disturbance.
3. How much topsoil is anticipated on being spread onto the site as part of the proposed landscaping work?
4. Chapter 129, Property Maintenance, of the Brighton Town code indicates that all land shall be maintained so as not to alter the existing flow rates, peaks, quantities or direction of storm drainage. The topography or surface quantities of an area shall not be modified so as to alter the water retention characteristics of the property. The proposed landscaping work shall be consistent with this requirement.
5. A silt fence detail should be provided on the plans.
6. A tree planting detail should be provided on the plans.
7. No additional clearing shall occur within the Town right of way.
8. The location of the designated "work zone" that is referenced in the workplan developed by Josh Landscaping should be called out on the plans.
9. Will any additional trees on the property be removed as part of the proposed work?

The following notes should be added on the plans:



In regards to the Application of Nicholas Leonardo, owner, for EPOD (woodlot) Permit Approval to remove brush, ground debris stumps and dead fall and to spread topsoil and hydro seed property located at 851 Clover Street, we offer the following comments:

Please be advised that several neighborhood residents take exception to the notion of "eliminating" the characteristics of the WoodLand Lot designation that pertains to 851 Clover Street. While the owner has done an outstanding job with the property, the land was purchased knowing full well that it was to remain a wooded lot.

The additional removals, topsoil and establishment of turf may sound great, but in reality it would completely alter the look of the wooded lot. In essence, the lot would become yet another suburban landscape.

We would suggest that the owner continue with his scheduled tree plantings supplemented by the addition of 3 additional trees in and around the SE corner (entrance) that were removed by accident during construction. We also suggest that he maintain a 10-20 foot "woodland" buffer around the perimeter of his lot. What this would entail is either a denial of the proposed clearing under 7P-03-21 or a slight compromise to ensure a wooded buffer is maintained.

In addition to the three (3) trees that were inadvertently removed during construction, the towns ROW needs to be regraded and restored to its original condition. We would suggest that after the 10 ft wide driveway is installed the ROW be hydro seeding with a wild flower mix.

Dear Mr. William Price and Mr. Ramsey Boehner,

As Brighton residents since 2004, and lifelong residents in the western New York region, we wanted to provide comments to the Brighton Planning Board regarding the upcoming 7/21/21 site application review for the Planned Parenthood of Central and Western New York medical clinic.

Note, to provide full transparency, one of this letter's authors, Jamie Kerr, MD, is a retired Internist and member of the PPCWNY Board of Directors. We also both receive our medical care at the proposed location under review, a multi-site medical campus, as do other family members.

Although the minutes of the Planning Board meeting on 6/16/2021 are not yet available, we were able to review the video recording of the meeting and listen to participants concerns and feedback.

So, in response to the stated objections and in ***support of this proposal acceptance***,

1. We affirm that Brighton is a tolerant and inclusive community which listens to diverse opinions with respect
2. We regard our residence in Brighton important for its access to high quality medical care, and as a basic right not to be regulated away or prevented by the beliefs of others
3. We support the efforts of Planned Parenthood of Central and Western New York to provide high quality evidenced based reproductive health care and access to safe and legal abortion care in our community
4. We understand and expect the Brighton Planning Board to follow its legal responsibility to review the site application and not pre-empt NYS Law
5. We listened to comments against the site application which were overwhelmingly based on personal beliefs and values which we acknowledge are deeply held and are protected speech. However, the law is clear.

In January 2019, the Reproductive Health Act was signed into law in New York. The law states as follows:

"The legislature finds that comprehensive reproductive health care is a fundamental component of every individual's health, privacy, equality. Therefore, it is the policy of the state that:

1. Every individual has the fundamental right to choose or refuse contraception or sterilization,
2. Every individual who becomes pregnant has the fundamental right to choose to carry a pregnancy to term, to give birth to a child, or have an abortion, pursuant to this article.
3. The state shall not discriminate against, deny or interfere with the exercise of the rights set forth in this section of the regulation, or provision of benefits, facilities, services or information."

Furthermore, based on comments from the Town Attorney present at the meeting, the Planning Board has the responsibility to review the site specifications; it is not the purview of the Planning Board to review the type of medical services provided which are compliant with NYS law.



It has come to my attention that Planned Parenthood of the Fingerlakes is attempting to move into the town of Brighton. I realize that this move is creating quite a stir in the greater metropolitan area of Rochester as well as the town. It has also created quite a reaction in the church I am currently pastoring, Brighton Presbyterian Church. This church's roots extend to the time of the revolutionary war and its first pastor, Solomon Allen, served with General George Washington as a Colonel. He served those early pioneers and settlers in the wilderness of Brighton and the surrounding area from 1805 until 1820. He was known as a pastor to the poor and the lonely. The original membership of the church included fathers of those who went on to care for the poor and needy. One family the Bloss's were actively involved in the abolitionist movement and the underground railroad. Its membership fought for women's rights and the vote.

This passion for the least and most needy continue today. The church houses three ministries that serve the addicted and troubled.

Though Planned Parenthood spins its services as needed healthcare, it has a sordid past. Every year 345,000 children die in its facilities. A majority of them are minority babies. Its founder, Margret Sanger targeted the poor, calling them human weeds. As an organization, it has been involved in programs and policies that have targeted the population of the black race for reduction.





I wish to offer you the following resolution for your desire to occupy the space... located at [2041 Clinton Avenue South](#) located in the Town of Brighton.

Within 30 days the following items shall be addressed and in full compliance with the Codes of New York State.

1. The ADA parking space provided shall have a sign with the international symbol of accessibility complying with 703.7.2.1 mounted 60 inches minimum above the ground surface measured to the bottom of the sign.



2. The ADA Access aisle shall have a sign in compliance with BCNYS Section 1111.5 (Provided below)

[NY] 1111.5 Access aisle signs. Each access aisle shall be provided with signage reading "NO PARKING ANYTIME." Signs shall be permanently installed in accordance with ICC A117.1 and shall not interfere with an accessible route from an access aisle.



3. An ADA compliant sales or service counter must have a portion that is **28"-36" inches high**, measured from the finish floor to the sales counter top. This portion of the counter must also be at least 36" inches long for a parallel approach or a 30" length for a forward approach.

4. All non operational smoke detectors and any other fire alarm system component shall be removed from the building as described in Section 107.1.1

FCNYS [NY] Section 107.1.1 Existing nonrequired safeguards. Wherever any nonrequired device, equipment, system, condition, arrangement, level of protection, or any other feature is provided, such device, equipment, system, condition arrangement, level of protection, or other feature shall, thereafter, be continuously maintained in accordance with this code and applicable referenced standards or shall be removed in its entirety.

Exceptions:

1. Nonrequired devices, equipment and systems are permitted to be removed in entirety;
2. Nonrequired devices, equipment and systems are permitted to be disabled, provided that all visible elements are removed;

5. Portable Fire Extinguishers shall be provided and appropriately mounted on each floor with a current inspection tag by a licensed City of Rochester Fire extinguisher vendor.

6. Provide a code compliant water resistant enclosure or other acceptable code compliant alternative, approved by the Town of Brighton Fire Marshal, around the electrical disconnect panel located inside the newly renovated ADA compliant restroom facility.

7. The front vestibule door is currently outfitted with a thumb turn locking device, please remove the device or replace with ADA compliant hardware which does not require a person to grasp, pinch or twist the wrist to operate.

8. Provide a letter from your electrician that the battery backed up emergency lighting is installed and operational and provides a minimum of 90 minutes of illumination as required by Section 1031.10.2

FCNYS Section 1031.10.2 Power test. Battery-powered emergency lighting equipment shall be tested annually by operating the equipment on battery power for not less than 90 minutes.

Once you have a plan for compliance please request a re-inspection prior to Thursday August 19, 2021, that is when your temporary Certificate of Occupancy shall expire.

A copy of this email will also be provided to the secretary of the planning board for their review and understanding, as this property also has a pending application for a future project.

If you have any questions or have these items corrected earlier please feel free to contact me back directly to schedule a mutually agreeable re-inspection date.

Dear Mr. Boehner:

I had an opportunity on June 16, 2021 to address some of my concerns with the proposed demolition of a building located at 2233 South Clinton Avenue in the Town of Brighton, and the construction of a new building on the same site for use as a facility for Planned Parenthood.

Both my office and my home are in the Town of Brighton. I have been a resident of the Town of Brighton for more than 50 years. I frequently drive by the proposed site of the planned abortion facility. I am vigorously opposed to the construction of a Planned Parenthood abortion facility in the Town of Brighton.

According to your letter dated June 21, 2021 to Mr. Tom Fromberger of MRB Group and to Westfall Medical Realty, at first glance it appears that the Planning Board wants very detailed information, even to the issue of proposed landscaping and landscape maintenance. However some issues were not address.

Among the issues not addressed, which should be addressed, are the following:

A. What are the plans for the disposal of "medical waste" such as the remains of an aborted fetus?

B. Will there be an environmental impact study on the production of the "medical waste" from abortions to be performed at this abortion facility?

C. Will the facility be used for second and possibly third trimester abortions?

D. Will the facility be used for the performance of medical experimentation and research on the fetus of an abortion patient?

E. Will any of the "body parts" that are the product of an abortion be marketed and sold by Planned Parenthood from this facility, as has apparently happened elsewhere?

F. Will there be an environmental impact study on the increased volume of traffic that an abortion facility such as Planned Parenthood would likely produce?

G. The University of Rochester and other medical providers currently have a large number of medical buildings in the Town of Brighton and in the near-by Town of Henrietta and in the City of Rochester to serve the various medical needs of a large population, so why is another abortion center desired for the Town of Brighton?

I. I have observed that there are no sidewalks on South Clinton Avenue in the area of 2233 South Clinton Avenue. Since it is logical to presume that pro-life protestors will frequent the site, how will the Town handle the issue of traffic safety to both walking protestors and motorists on South Clinton Avenue? Will the Town conduct any studies and suggest proposals to resolve these traffic and pedestrian problems.

I urge the Town of Brighton and the Town Planning Board to give serious considerations to these issues that I have raised. The Town of Brighton should support a medical facility that promotes healing and life, and not one that is the largest providers of deadly abortions.

I am a Brighton resident writing to voice my strong support of the new Planned Parenthood healthcare center opening in our community.

As a young woman who just started working as a public school teacher and has moved several times before my job, I know how difficult it is to find reliable and affordable healthcare that accepts new patients and a particular insurance plan, particularly providers for women's health. Planned Parenthood is a trusted, well known healthcare center that most women are familiar with, including young women who are even more unlikely to have a trusted and consistent OBGYN practitioner.

I have done my own research in recent years trying to find legitimate and transparent medical offices who are non-judgmental and without a particular religious affiliation to provide honest pre-pregnancy and pregnancy counseling and medical/emotional support for patients trying to plan their futures. Most offices in our area do not fit this criteria, and the closest location I could find was the single PP in Rochester. I was thrilled when I found out that one was going to open in my town, and I will most likely go there if/when I ever decide to become pregnant.

As a middle class woman, I have the time, transportation, and insurance that enables me to find a doctor (and it's still difficult). Unfortunately this is not the case for most people. Planned Parenthood has been one of the few reliable healthcare centers for people across the country. 
