CONTINUING BUSINESS

Park Issues: Matt Beeman

- The Parks Department has been occupied performing upgrades to park buildings.
- Floors have been refinished at Brighton Town Park and the oil tank has been removed to prepare for the transition to a propane heating system. In addition, the back deck and stairs have been rebuilt
- Buckland Park Lodge floors are currently being re-done, and a Scissor Lift has been rented to perform a thorough cleaning of the beams, lights, fans, and other elevated areas.
- In an effort to improve sustainability, all lodge bulbs are being updated to LED to reduce the frequency of replacement and increase energy efficiency.
- Buckland House touch ups being done—the walls are being repaired, painted, and art wall-hanging system installed
- As the weather allows, the Twelve Corners Gazebo work that commenced in the late Fall will be finished, and painting will occur later this spring.

- There is an Office Clerk III Civil Service employment opportunity available in the Brighton Recreation Department. Canvass letters have been distributed to eligible candidates, with minimal responses. Interviews are planned for next week.

Brighton Complete Count Committee (2020 Census) Update

- The 2020 Census is in full swing!

- A complete count for Brighton will ensue that we can take advantage of all of the critical funding for which our community is eligible.
- There are ambassadors in our communities who continue to raise awareness about how you can take part in the census. In particular, if you are someone who spends time out-of-state this time of year to avoid the weather, make sure that you complete your census for the area where you spend most of your time.
- By the time we celebrate on April 1, 2020, we hope that most everyone will have already participated online, or by phone, or in person.

Brighton Opt in to Rent Stabilization (Emergency Tenant Protection Act – EPTA)

- Tabled, and removed from the agenda for the time being.

Community Services Committee Website Update

- Working with Barb Snyderman and Bridget Monroe to implement the needed updates.

Mobile African American History Display Update

- Designer/Artist identified to design the mobile display boards for the Town.
- Working with the Town Historian to clarify any connections that Frederick Douglass may have to Brighton.

Territory Acknowledgment Update

- Ongoing conversations Ronnie Pollack of the Native American Cultural Center to identify a potential spring date for an event to meaningfully roll out the practice of Territory Acknowledgment in Brighton.
- Considering a program that has significant tie-in to the Council Rock

NEW BUSINESS

Disavowal of Restrictive Covenants

- Discussions among Town staff regarding how to proceed with disavowing the restrictive covenants within existing deeds without otherwise affecting the chain of title.
- The goal is to develop a blanket disavowal clause to that would renounce any and all racial, ethnic and religious restrictive covenants included on any existing deeds in Brighton. It would not have any legal binding force (as the restrictive covenants are already unenforceable), but it would represent a significant symbolic acknowledgment of the values of the community.
- We will look to work with the County and ensue that Title Companies are consulted as we consider how to take action on this.

GFL AWMA (Genesee Finger Lakes Air & Waste Management Assoc.) Earth Day Grant Application

- **Deadline:** March 2, 2020
- Worked with Town Engineer, Evert Garcia, and Commissioner of Public Works, Mike Guyon, to complete the application for this grant that will award up to \$750 to increase environmental

education through projects that promote: 1) environmental awareness and consciousness, and 2) the development of technical knowledge and skills and sustainable environmental practices.

- Clean Sweep has previously been the recipient of awards under this grant program.

Town Historian's Report from Mary Jo Lanphear
