**RE: PARKS SUPERINTENDENT'S REPORT** – reported by Matt Beeman

The Town has re-opened lodges in April 2021 to a 25-person limit but are struggling with compliance, if problems persist, continued use may be in jeopardy. Field use is high as youth sports are re-starting. Occupancy requirements of no more than 2 spectators per participant is being monitored by each User Group. Summer soccer is planning to start at the end of June. Brighton Baseball currently has over 280 participants signed up. No tournaments are planned for the summer at this time. 4<sup>th</sup> of July celebration plans are currently underway. 5K has been cancelled and the schedule of events will be reduced due to the current pandemic restrictions. Memorial Day dedication will proceed at Buckland Park.

**RE: RECREATION DIRECTOR'S REPORT** – reported by Becky Cotter

Modified summer programs to be implemented in accordance with the Monroe County Department of Health guidance. Two programs to be held at FRES, programs will also be held at the School District Administration Building, TCMS and Brookside School. Programs will be run in 2-week blocks and will maintain a POD format to maintain social distancing. Electronic registration going well and most spots are already filled by Brighton Residents. Concert series is planned and most dates are already filled. Attendance to be limited to 200. Fishing Derby is planned for the Town Park with pre-registration required.
