### **CONTINUING BUSINESS**

#### **Park Issues: Matt Beeman**

- Parks and trail maintenance is ongoing
- Working with Seneca Park Zoo Trail Cams Program to bring focus on urban wildlife in Corbett's Glen and Brickyard Trail with the potential that the cooperation may evolve to future programs
- Discussion of plans to restrict the July 4<sup>th</sup> Road Race to Meridian, due to RG&E construction on S. Winton, or to explore an alternate road route.

#### **Recreation Programs: Rebecca Cotter**

- Program Registration is ongoing
- Spring Events planning is underway. Brickyard Bunny Trail event programming expected to return.
- Summer Planning is also underway, including Concert Series, Day Camp, Staff Recruitment, etc...
- Feasibility Study work continues. Expect the next public meeting in a month, or so
- Grab and Go Senior Meal Program – Developing partnerships with Senior Living Communities to offset costs and creatively partner to host a lunch program on location at various sites in the community.
- Masking protocols discussion for Town programs and rentals, as state directives evolve
- Summer Market and the potential impact of the RG&E construction project discussion

### **Winter Farmers' Market Update**

- Next phase planning underway, expect to go out to bid early Summer
- Working toward synergy between the Feasibility Study feedback and the Winter Market project

### **Inclusion, Diversity and Equity Advisory Board Update**

- Draft Final Report Presentation

### **Community Choice/Community Solar Aggregation Update**

- Ongoing billing issues with RG&E and Source Power
- Working to get resolution for residents
- CCA has worked very well
- Community Solar Aggregation with Source Power is experiencing significant challenges
- RG&E is working to rebill to remove adjustments to correct the issue
- Discussion of the parameters for providing true resolution of those issues to our affected residents

### **CEC Community Priority Actions/Sustainability Funds Update**

- Our CAP consultant, Barton & Loguidice, issued a survey to SOC, IDEA Board, Directors and Staff to compile a list of community contacts for targeted outreach, engagement, and input on the CAP
- Draft community engagement plan has been provided and SOC is reviewing this plan at its 2/22/22 meeting.

### **Urban League of Rochester/ESL/Town of Brighton First-time Homebuyer's Program Update**

- Key Bank in process of revising their community mortgage program and hope to come up with something that is tailored to our community.

- Tabled until spring

### **Clean Sweep 2022 Update**

- Will be meeting with Betsy Balling at BCSD to coordinate busing for students
- Registration through the Recreation portal will be set up and open to the community in March
