#### **Brighton Ambulance –**

The following information outlines the activities for Brighton Volunteer Ambulance for August, 2022.

- Brighton Volunteer Ambulance received a total of 675 requests for service throughout the month of August, with a total of 520 being within the Brighton Ambulance District, with 269 Brighton Residents receiving services.
- A total of 150 requests for Mutual Aid were received for surrounding ambulance districts. Of those 150 requests, Brighton Volunteer Ambulance responded to 65 calls for Mutual Aid.
- Code 32 reserve policy was applied 68 times. Of those 68 occasions, BVA staff were able to respond to 46 calls within the district that otherwise would have been assigned to mutual aid, showing an efficacy of 68%.

- Total Brighton Volunteer Ambulance requests for service up to September 1st is 5,480(an increase of 16.6% from 2021 volume, 2.2% from this month last year).
- EMS staffing continues to be a challenge on a local and national level.
- Collaborative meetings between the regional agency leaders are ongoing.
- Training sessions have been scheduled with HFD and continue with BFD
- Mental Health First Aid Instructor training will begin in October, with plans to offer Mental Health First Aid training to all local agencies and the local public.

## **OLD BUSINESS:**

### **RE MATTER: RGE Winton Road Gas Main Replacement Project – UPDATE**

*Mostly through 12 corners and working along South Winton and plans are to have this paved this year, as blacktop will be available through the month of November. This project has been fairly smooth with minimal interruptions to traffic.*

### **RE MATTER: Community Services / Concerns & Trends**

*An update around every day shoplifting and crime surrounding these activities. BPD suggested that there are actions could be taken by vendors to place the high theft products behind counter or in secure areas of the facility.*

*Catalytic converter thefts continue to be of concern. BPD is investigating the use of etching kits and try to reduce the resale and being able to tracking of stolen equipment.*

*Discussion on video surveillance and quality of video to assist with identification of suspects, most time this video is low quality or lack clarity.*
