My name is Mary Arcidiacono and I am the property owner of 2831 W Henrietta Rd which contains Gold4cash and the Tsing Tao House Restraunt. I apologize I wasn't able to make it to last weeks meeting, I wasn't feeling well but I am back in the office today and saw the hearing notice and it reminded me I needed to email you. So my concerns with a convenience store going into that location is as follows:

**Parking-** There is already a serious parking issue in regards to that building. There is no were near enough parking for the three businesses and two apartments so my parking lot has customers of those business in it pretty much all day long and this was the case when a small retail cellphone store was there. If a convenience store goes in there, it will be way more in and out traffic which will only spill into my parking lot. Decreasing the spaces for my and my tenants parking, adding to wear and tear on my parking lot and not to mention the litter.

**Traffic-** This area of west henrietta rd is already crazy enough, with an accident happening out front of the building multiple times a week, as a matter of fact there was one today, two saturday and two friday. There is no light here so again with so much in and out traffic of a convenience store that will only increase the craziness and the amount of auto accidents in the area.

**Garbage-** This property currently has two garbage and recycling toters for the two apartments upstairs, one for the spa and then one dumpster that is for the bubble tea place. The dumpster is actually in one of the parking spots, with no coral, no fence and no kind of barrier of any kind. I know this is against town code, being there is no recycling, so all the cardboard from the business is being thrown away, there is no coral so all the garbage that blows around ends up in my landscaping, parking lot and neighboring properties and its taking up a parking spot. So I am not sure how that keeps getting over looked but if there is another business that turns over a lot of cheap products then they will need a dumpster also. Would this one end up in another parking spot or be fenced in to keep all the garbage at bay?
