**Brighton Ambulance**

The following information outlines the activities for Brighton Volunteer Ambulance for December 2023.

- Brighton Volunteer Ambulance received a total of 748 requests for service throughout the month of December, with a total of 569 being within the Brighton Ambulance District, with 329 Brighton Residents receiving services.
- A total of 170 requests for Mutual Aid were received for surrounding ambulance districts. Of those 170 requests, Brighton Volunteer Ambulance responded to 47 calls for Mutual Aid.
- Code 32 policy was applied 83 times. Of those 83 instances, BVA responded to 49 calls within the Town of Brighton at that time showing an efficacy of 59%.
- Total Brighton Volunteer Ambulance requests for service up to January 1st is 8,494 (a decrease of 3% from 2022 volume).
- Webster EMS is set to shut down by 3/31/24. This is expected to create a significant draw in Mutual Aid in the coming weeks and until a permanent solution is found.

### **Brighton Police Department**

Calls for service to end of December 2023: 50,671 (preliminary numbers will be verifying)

- We are closely monitoring today's (Tuesday 1/9/2024) expected wind event.
- Edgewood Av Traffic Details:
  - 18 tickets over 9 days
- Penfield Road Crash Data
  - 43 crashes over 5 years
  - 9 injury crashes
  - 3 involving bicycle pedestrians.

## Henrietta Fire District

### 2023 Data

- 7,193 total responses, down ~4% from 2022. This is attributed to a change in EMS coding which resulted in ~600 fewer EMS responses vs the year before and fewer severe weather responses.
- 964 responses in West Brighton, up 15%. Part of this can be attributed to an increase in responses to MCC ( up ~28% over 2022) and a ~300% increase in responses to Helio Health at 1850 Brighton Henrietta Townline Rd
- 42% of the time, we were operating at 2 or more calls simultaneously in the district
- \$57K grant secured for upgrades to the West Henrietta Rd station, with those anticipated to begin in the first quarter.
- As of January 1st, staffing is 73 career firefighters and officers, 51 volunteer firefighters and officers, 4 career dispatchers, 2 administrative staff, 1 mechanic.
- A more detailed 2023 summary will be provided for the next meeting.

## OLD BUSINESS:

### OLD BUSINESS:

**RE MATTER: Update** - Crosswalk - Highland Avenue: @ Grosvenor Rd, Pelham Rd, and Council Rock Ave.

*Commissioner Garcia provided a draft copy of the Town of Brighton sidewalk policy for review and possible adoption. Some discussion about how a request was to be filed, by a neighborhood association, if available, or smaller number of area representatives, such as 5 residents instead of 10 residents as detailed in the draft proposal.*

*If adopted, this would need necessary future budget funding as staff time and resources will become part of the review process and then costs to implement the crosswalk installation itself.*

**RE MATTER: Update** - Traffic signal at North Landing and Blossom Roads.

*NYS DOT is reviewing the request and will report back to the committee upon response to the agency's findings.*

**RE MATTER: Update** - Edgewood Ave's aggressive drivers & potential solutions – DC Desain

*Neighborhood Petition with signatures has been forwarded to Monroe County DOT. Once the request has been reviewed an update will be provided back to the committee.*

## **NEW BUSINESS**

**RE MATTER:** Crosswalk Penfield Road – Werner

*The request for sidewalks and crosswalks has also been forwarded to Monroe County DOT for review and possible implementation of a future crosswalk installation once required improvements by the Town of Brighton at Forest Hills and Penfield Road have been completed. Brighton Police provided some traffic and accident data with 91% of the traffic captured within tolerance of the posted speed limit.*
