

We look forward to the Public Committee discussion to resolve some issues making sure public pedestrian and bicycle access and circulation are given highest priority over vehicles and parking. 

Bill - good morning. I know you recall the Planning Board's heartburn with the proposed site plan presented in July. I don't want to complain or voice concerns without offering some concepts that address those concerns. Attached is a rough plan for your review and discussion with staff, the library and police. Primary points,

- relocated west entrance from Elmwood. This reduces the amount of traffic (and conflict points) at the front of the library.
- with removal of the pool the pedestrian and bike circulation can be directed to the front of the library and keep pedestrians out of the travel lanes north of the library.
- keep and renovate the pool building for equipment and restrooms for the splash pad.
- Playground equipment shifts slightly east from current location.
- New gazebo location allows shade and observation point for parents whose kids are on playground or at splash pad.
- Relocate dumpster in an enclosure so trucks have direct access. Offers better access for staff coming out of town hall.

- Relocate shed to east end of back parking. Relocating the dumpster and shed allow parking spaces for playground and splash pad.
- Remove narrow island behind the police station and increased parking for police.
- Reorient parking in front of police for traffic calming purposes. I don't personally agree with this expense but it is part of the site I can't see daily like the rest of the site.
- Reorient the parking between Elmwood and library so for more parking in essentially the same footprint. Relocate EV charging to this area.
- There are two options for library book drop off; one walk up with a canopy over the slot and one (upper right on plan) that keeps the drive thru. Our observations are that there are equally as many people who drive up and walk up currently. Many drive and get out of their car to return books.

I hope this prompts some conversation for stakeholders. The planning board remains interested in the site committee and public engagement in this process. I personally (as a close resident to the site) agree with the decision to abandon the pool for a splash pad and disagree with (mis) information being circulated in Roselawn. I would be happy to state that publicly if it would help. I do think the Community Recreation Plan should be finalized and adopted by the Town Board. I know it addresses many of the issues raised by opposition from this neighborhood. Happy to discuss further. Bill

Re: Vibration Compaction – repaving on Kirk Drive

Dear Bill:

The homes at 18, 50, 78, 85, 89, and 104 Kirk Drive are each over 80 years old, and except for 104 Kirk, are constructed of stucco over concrete block. The exception, 104 Kirk, is a brick home. Each of the homes interior walls are primarily finished with plaster.

Over the past 50 years, Routes 490 and 441 have been built and re-built on several occasions. This process involved the milling of the asphalt and its replacement with new asphalt pavement. In each case, the pavement was compacted using power rollers equipped with a vibration compaction feature.

The use of VIBRATION COMPACTION rollers has caused significant damage to our homes in the form of cracked interior and exterior walls. The last major rebuild and expansion of Rte. 490 about 25 years ago resulted in over \$75,000 in interior damage to my home alone plus that of my neighbor at 89 Kirk our homes. The last milling and repaving in 2022 resulted in over \$10,000 in interior damage (cracks) to my home at 85 Kirk.

Due to the documented losses sustained by Vibration Compaction to our homes, we are requesting this construction technique not be used by the Town of Brighton and its contractor when Kirk Drive is milled and repaved in 2025. This would include not only the Vibration Compaction rollers but also the use of this technique by the asphalt spreader.

Please pass on this letter to your highway superintend, the contractor and any others involved in dealing with this request.
