**Brighton Ambulance**

February 2025

- Brighton Ambulance received a total of 745 calls for service in the month of February 2025 with a total of 578 being in the Brighton Ambulance district. Of these calls 299 were Brighton residents.
- A total of 167 requests for Mutual Aid were received from surrounding ambulances. Of these Brighton responded to 82.
  
- Code 32 was applied 85 times. Only 1 call was dropped to Mutual Aid with a 99.102% efficacy.
- Brighton total call volume in February 2024 was 622, and 745 in February of 2025, with a increase of 6.555%
- Brighton has added 5 Cleared providers to our roster, with 6 still in the Hiring and clearing process.

### **Brighton Fire Department**

- Calls to Date: 146
- No calls of significance
- OSHA Training continues to go well
- Request from Brighton PTSA for their Auction. The past two years we offered a ride to school in a fire truck as one of the auction prizes.
- We have several members taking advantage of County training offers in February and March
- District Safety Committee meet on 23 DEC. Discussion of some minor accident with apparatus and minor injuries for the past two quarters. Next meeting set for March.

### **Henrietta Fire District**

- District wide calls through February: 1086
- Calls in West Brighton through February 28: 136

- *Calls of note in WB: 2/21 serious motor vehicle accident at West Henrietta and Furlong Rd. Units arrived to find a 2-car crash with one vehicle on fire and people down in the road. Firefighters dragged one person away from the fire to safety. 5 total injuries, at least 3 of which were serious, but not life threatening, including a 3-year-old. While this was going on we also handled a serious structure fire at the opposite end of the district, which necessitated multiple mutual aid companies.*
- *Started a new career fire academy class on Monday. 20 students' total. Students are from Henrietta, Gates, North Greece, Lakeshore, Rochester Airport, Canandaigua, Geneva, Victor. The class will run through May 30th and encompasses over 500 hours of training.*
