The resolution, a summary of which is published herewith, has been adopted on May 8, 2019 by the Town Board of the Town of Brighton, Monroe County, New York, and the period of time has elapsed for the submission and filing of a petition for a permissive referendum and a valid petition has not been submitted and filed. The validity of the obligations authorized by such resolution may be hereafter contested only if such obligations were authorized for an object or purpose for which the Town of Brighton is not authorized to expend money or if the provisions of law which should have been complied with as of the date of publication of this notice were not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of publication of this notice, or such obligations were authorized in violation of the provisions of the Constitution.

SUMMARY OF BOND RESOLUTION

Set forth below is a summary of said resolution adopted by the Town Board of the Town of Brighton on May 8, 2019.

1. The resolution is entitled "AMENDED AND RESTATED BOND RESOLUTION OF THE TOWN BOARD OF THE TOWN OF BRIGHTON, MONROE COUNTY, NEW YORK (THE "TOWN"), AMENDING AND RESTATING IN ITS ENTIRETY A BOND RESOLUTION OF THE TOWN DATED FEBRUARY 24, 2016, AUTHORIZING THE TOWN TO UNDERTAKE THE CONSTRUCTION OF THE HIGHLAND PARK CANALWAY CONNECTOR TRAIL (N/K/A HIGHLAND CROSSING TRAIL) PROJECT; ESTIMATING THAT THE TOTAL COST THEREOF IS \$2,614,500; APPROPRIATING SAID AMOUNT THEREFOR; AND AUTHORIZING THE ISSUANCE OF \$450,000 IN SERIAL BONDS OF THE TOWN TO FINANCE SAID APPROPRIATION".

2. Object or Purpose: the construction of the Highland Park Canalway Connector Trail (n/k/a Highland Crossing Trail) Project within the Town and the City of Rochester from the Erie Canalway Trail along municipal properties and easements to the Genesee Riverway Trail, connecting both trails to Highland Park, including the construction of sidewalks and shoulders along existing roadways, and including costs incidental to the financing of the foregoing.

3. Period of Probable Usefulness: 15 years.

4. Amount of Debt Obligations Authorized: \$450,000 (an increase of \$350,000).
