

PLEASE TAKE NOTICE that the Town Board of the Town of Brighton will hold a public hearing on April 10, 2013 at 7:30 pm or as soon thereafter as it can be heard at the Brighton Town Hall, 2300 Elmwood Avenue, Brighton, New York on the following matter: The Proposed Elector Initiated Dissolution Plan for the West Brighton Fire Protection District which plan can be viewed in its entirety at the West Brighton firehouse located at 2695 West Henrietta Road and at the Monroe Community College, Building # 1, 3<sup>rd</sup> Floor, 1000 East Henrietta Road, both of which are located within the West Brighton Fire Protection District as well as [www.townofbrighton.org](http://www.townofbrighton.org). A summary of the plan is as follows:

The entity to be dissolved is the West Brighton Fire Protection District. The territorial boundaries of the West Brighton Fire Protection District are that part of the Town of Brighton, County of Monroe, State of New York that is North of the Henrietta Town Line, South & West of the Erie Canal, South & East of the Genesee River. The fiscal estimate of the cost of dissolution is \$6,000.00 for publication, professional services and disbursements from the process of dissolution plus start up costs estimated by the Henrietta Fire District at approximately \$200,000.00. The position of District Administrator for the West Brighton Fire Protection District would be eliminated upon dissolution. The assets of the West Brighton Fire Protection District including funds in the approximate amount of \$1,641,134.00, Fire Engine 503, and all of the assets acquired from the West Brighton Fire Department, Inc. including all real property, including but not limited to real property located at 2695 West Henrietta Road and at 41 Riverside Drive, all fixtures and equipment of any kind and all other assets, including but not limited to all funds of any kind are to be transferred to the Henrietta Fire District. The Henrietta Fire District proposes to absorb the current area located in the Town of Brighton and known as the West Brighton Fire Protection District into the Henrietta Fire District. Upon the effective date of the dissolution of the West Brighton Fire Protection District the boundaries of the Henrietta Fire District would be simultaneously expanded to include those areas formerly included within the West Brighton Fire Protection District. Thereafter fire service and first response to medical emergencies would be provided within such area by the Henrietta Fire District. Services will be provided by a combination of career paid fire fighters and volunteers. Volunteer members of the West Brighton Fire Department will be welcomed to apply for membership as volunteers in the Henrietta Fire District. The Effective Date of Dissolution will be approximately three months following the final adoption of this dissolution plan, contingent upon a final non-appealable Court Order directing the West Brighton Fire Department to transfer assets to the Henrietta Fire District. The Public Hearing on this Proposed Dissolution Plan will be held on April 10, 2013 at 7:30 pm or as soon thereafter as the hearing can be held at the Brighton Town Hall, 2300 Elmwood Avenue in the Town of Brighton, County of Monroe, State of New York.
