UTILIZATION OF TRUSS TYPE CONSTRUCTION, PRE-ENGINEERED WOOD CONSTRUCTION AND/OR TIMBER CONSTRUCTION IN RESIDENTIAL STRUCTURES

When truss type construction, pre-engineered wood construction, and/or timber construction is to be utilized in the construction of a new residential structure, or in an addition to or rehabilitation of an existing residential structure; the owner of such structure, or the owner's duly authorized representative, shall notify the authority having jurisdiction of that fact. Such notice shall be in writing and shall be provided to the authority having jurisdiction prior to the issuance of the certificate of occupancy or certificate of completion for such project.

The property owner or the property owner's representative shall complete the attached form and submit to the Town of Brighton's Building Department or to the Town of Brighton building inspector, prior to final inspection. Before the final inspection, the sign shall be affixed to the electrical box attached to the exterior of the residential structure. In the instance where the electrical service does not allow for the sign, or is not present on the exterior of the residential structure, the sign shall be located in a place that is likely to be seen by firefighters or other first responders. The location shall be approved by the building inspector or the Fire Marshal.

The maintenance of this sign, and the area adjacent to it, shall be the responsibility of the property owner. An example of the sign can be seen below.
